Statement of Commitment

We believe that every person has the right to take part in gymnastics in a safe, supportive environment, free from abuse, neglect, harassment, discrimination, bullying, hazing, exploitation or non-accidental injury. This applies to children, young people, adults at risk, and all participants — regardless of age, gender identity, sexual orientation, disability, religion, ethnicity, or background.

IGA and its affiliated clubs are committed to safeguarding and promoting the welfare of all participants — children, young people, and adults at risk — across all activities, settings, and nations in which we operate.

Scope & Who the Agreement Covers

This agreement applies to:

- The affiliated club named below, including all staff, coaches, volunteers, officials, contractors, and event partners.
- All participants (children and adults at risk) engaged in club activities, and their parents/carers.
- · Any third-party organisations or individuals providing services on behalf of the club or IGA.
- All settings where club activity takes place: clubs, community venues, events, competitions, training camps, trips, transport, online/digital activities and communications.

Core Safeguarding Commitments and Standards

By signing this agreement, the club confirms it will:

- \bullet Prioritise welfare the safety and wellbeing of children, young people and adults at risk is paramount at all times
- Protect all participants from harm including abuse, neglect, bullying, harassment, discrimination, hazing, exploitation or non-accidental injury
- Create an inclusive environment treat all participants with dignity, equality and respect, with zero tolerance for discriminat

Ensure safer recruitment – including:

- Mandatory background checks (e.g. DBS/PVG/AccessNI/Garda vetting according to jurisdiction)
- · Role-appropriate references and qualification checks
- · Supervision and mentoring for those not yet fully vetted or qualified
- ory behaviour

Maintain up-to-date training - all coaches and staff to complete safeguarding training appropriate to their role

Deliver activities safely – including:

- · Age-appropriate and ability-appropriate coaching
- Safe coach-to-participant ratios



- · No lone working during regulated activity
- Robust risk assessments for all venues, equipment and activities
- Safe practice in physical contact (only where necessary and appropriate)
- Secure and responsible use of technology, photography/filming and social media

Provide clear reporting processes – all concerns or allegations must be:

- Reported immediately via club/IGA or statutory safeguarding routes
- Taken seriously and acted upon promptly
- Record and share information responsibly maintain confidential safeguarding records and share necessary information lawfully and proportionately
- Promote a culture of listening children and adults at risk should feel safe to speak up and know their voice is valued
- Support whistleblowers protecting anyone reporting concerns in good faith from victimisation or retaliation
- Work within approved governance and compliance processes fulfil affiliation requirements and implement updates to safeguarding procedures as they arise
- Engage parents/carers appropriately provide information about safeguarding and who to contact with concerns
- Ensure welfare throughout activities including during travel, off-site events, competitions, displays and digital participation
